





The Board of Trustees shall have power to acquire by purchase or on lease or otherwise any immovable property of any tenure and in case of vacant land they shall be at liberty to erect buildings there on and do all acts necessary and incidental thereto.

It shall be lawful for the Board of Trustees to pull down, renovate, rebuild, alter, adapt, improve, add-to, develop or repair any immovable property comprised in the trust properties and to expend these such moneys out of the Trust fund or the income thereof as they may think fit.



The Board of Trustees shall be entitled to enter into any agreement or covenants with owners or persons entitled to or interest in any other properties and raise funds by way of loan;

The Board of Trustees are authorised to collect any fees for carrying out the objects but only to meet the actual expenses incurred thereof.

All the policy decisions regarding administration of the Trust shall be made on unanimous vote by the Board;

The Managing Trustees shall function as the secretary to the Board of Trustees;

- a) Shall convene all the meetings of the Board including the sub committees if any, constituted by the Board.
- b) Shall prepare the agenda and minutes of the meetings and circulate the same;
- c) Shall see that the resolutions of the Board and other committees are put into execution;
- d) Shall carry on all correspondence in the Name and on behalf of the Trust and all communications meant for the Trust shall ordinarily be addressed to him.

The Permanent Trustees shall be persons to act for and on behalf of the Trust and to open and operate jointly the Bank accounts and to receive and to pay money on behalf of the Trust.

ACCOUNTS AND AUDIT:

The Trustees shall maintain proper accounts of the Trust on an annual basis and the same shall be audited by a Chartered Accountant appointed by the Board of Trustees. The accounts of the Trust shall be closed at the end of March every year.

The Trustees are authorised to invest the funds of the Trust in accordance with the provisions of the Income Tax Act 1961 and rules there under from time to time.

The trustees shall not carry any business with the funds of the Trust other than a business which is permitted under the provisions of the Income Tax Act 1961 not any of the funds or income of the Trust would be directly made available to the author of the Trust or other persons mentioned in section 13 of the Income Tax Act 1961 so as directly or indirectly benefit such person referred to in section 13 of the Income Tax Act 1961.

IRREVOCABILITY:

The Trust is irrevocable and no part of the funds of the Trust of income shall be taken directly for the benefit of the author of the Trust, his family or the Trustees.

GENERAL:

It is hereby declared for the removal of doubts that the benefits of the Trust shall be open to all without any distinction on the basis of caste, creed or religion.

It is also declared that any amendment to the Deed of Trust affecting the applicability of Direct Tax Laws shall be carried out on with the prior approval of the trustees.

The Trust shall not carry on any activity with the intention of earning profit.

If for any reason the objects of the Trust cannot be achieved or for any other reason thought fit by the Trustees the assets and liabilities of the Trust may be amalgamated with any other charitable organisation having similar objectives.

The author of the Trust, signed this deed at Madras on the day month and year mentioned above.


